CPC – Do you operate LGV's are and confused with the legislation?

1. Initial Qualification:

From 10th September 2009 all applicants wishing to obtain LGV status (categories C1, C1+E, C, C+E) and use the licence on a commercial basis, will be required to complete training and 2 modular exams (modules 2 & 4) to achieve Driver CPC 'Initial Qualification'.



2. Periodic Training:

Between 10th September 2009 and 10th September 2014 all current drivers who drive professionally are required to complete 35 hours (5 days) of training. On 10th September 2009 all existing Commercial LGV drivers gained their Driver CPC (DCPC). However, in order to keep their DCPC after 9th September 2014, and continue to drive professionally for the next five years after this date, they must have completed 35 hours of approved periodic training before this deadline. This “Approved Periodic Training” can only be delivered by organisations and training providers approved by the Joint Approvals Unit Periodic Training (JAUPT).
