Once the DVD had finished, Ken himself came in and there were some surprised people in the audience (not everyone was aware). Ken was his usual self, very honest, thought provoking, determined and incredibly succinct in what he was speaking about. Having toured the world over the years not only as a motivational speaker, but also investigating other accidents in businesses, he still speaks with passion today, as well as a fair bit of humour thrown in (never give directions to a guide dog!)



Ken spoke of the injury obtained, the investigation which followed, along with the treatment and rehabilitation he went through, before going back to work for the same company.

He took questions from the floor and made everyone think about their own actions, going forward, I think his message will have struck a chord with many people.

Ken could have spoken for the whole day, he was fascinated to know more about the RNC venue, as he didn't know it existed and hopes to work with them in the future to help other blind people know they can achieve so much.

Once the open question time had finished, Ken kindly stayed on to chat to others, before heading off for a rare evening at home.
